

# Journey and Milestones

Marwadi Education Foundation's Group of Institutions (MEFGI) was established in 2008 under the Bombay Public Trust Act 1950, as a significant entity of the Marwadi Education Foundation. Marwadi University is proudly promoted by Marwadi Shares and Finance Limited (MSFL), a prominent stock broking company in India, and Chandarana Intermediaries Brokers Pvt. Ltd. (CIBPL), a leading firm renowned for its technical and arbitrage trading expertise in Indian Stock Markets. In recognition of the institution's outstanding accomplishments, the Marwadi University Bill was passed in the Gujarat Assembly, leading to the establishment of Marwadi University on 9th May 2016, under the Gujarat Private Universities Act 9 of 2016.

Our University is one of the most prestigious institutions in the Saurashtra region, offering a diverse range of multidisciplinary programs, including UG, PG, PhD, Diploma and PG Diploma courses in areas such as Engineering and Technology, Science, Business Management, Computer Applications, Commerce, Arts, Law, Agriculture, Pharmacy, Physiotherapy and Nursing. With immense pride and pleasure, I would like to highlight that our MEFGI, an integrated campus, was bestowed with NAAC A+ accreditation in 2017. # Academics- Teaching & Learning

At Marwadi University, the teaching-learning process is centred on innovation, engagement, and student success. We adopt a learner-centric approach that integrates modern pedagogies, experiential learning, and the latest technological tools to create a dynamic and interactive academic environment. Our faculty members are dedicated to fostering critical thinking, problem-solving, and creativity through hands-on projects, case studies, and collaborative learning activities. By blending traditional instruction with digital platforms and industry-relevant practices, we ensure that students receive a holistic education that prepares them to meet the challenges of an ever-evolving global landscape.

In the academic year 2023-24, a total of 107 expert talks, guest lectures, and webinars were conducted for students, attracting 7,094 attendees and featuring 107 resource persons. Additionally, 45 workshops, seminars, conferences, and industry conclaves were organized, engaging 4,199 participants with the involvement of 63 resource persons. Various departments held 97 technical and academic events, which saw participation from 6,706 students. Moreover, 45 activities aimed at enhancing students' creative skills were conducted, with 2,695 students taking part.

At the department level, innovative teaching methodologies have been introduced, including open-book examinations, virtual reality labs, flipped classrooms, simulation-based teaching and assessment, and the integration of MOOC courses, among other approaches.

# **Research**

In the academic year 2023-24, Marwadi University welcomed 22 full-time and 82 part-time PhD scholars across various departments. The university made notable strides in research, achieving 416 publications in Scopus, WoS, and ABCD-indexed journals, presenting 122 papers at conferences, and publishing 76 books and book chapters. Additionally, 39 seed grants were awarded, with a total disbursement exceeding 84 lakh rupees.

Currently, there are 13 major ongoing research projects, comprising 9 national and 4 international initiatives, with a total of 12 faculty members involved. These projects have received funding amounting to ₹429.52 lakh. Additionally, the University has generated total consultancy revenue of ₹13,260,576 through material testing, environmental auditing, and environmental consultancy, serving 97 clients.

A total of 19 research sensitization sessions have been conducted, attracting participation from 929 faculty members and scholars. Additionally, Marwadi University currently has 36 junior and senior research fellows engaged in various fellowships, including Inspire, Shodh, funded projects, and MU-sponsored programs.

# **MUIIR**

Throughout the year, 88 designs were filed, with 83 being successfully published. Additionally, 49 copyrights were filed, leading to 39 registrations. In the realm of patents, 144 were filed, of which 5 were granted.

# Training & Placements

Marwadi University has consistently demonstrated outstanding achievements in placements and internships, securing opportunities for students with top-tier companies across diverse industries. Through strong industry connections and dedicated career support, we have facilitated high placement rates, with students being recruited by leading organizations. Our robust internship programs provide hands-on experience, allowing students to apply their academic knowledge in real-world settings, further enhancing their employability. The success of our placement and internship initiatives reflects our commitment to equipping students with the skills, knowledge, and industry exposure needed to thrive in today's competitive job market.

During the academic year 2023-24, Marwadi University organized 26 career counselling programs focused on enhancing student employability and skill development, with participation from 1,383 students. The University's placement efforts attracted visit of 350 companies and 151 multinational companies.

These initiatives resulted in our students securing 124 "Dream" offers with salary packages ranging from ₹5 to ₹6.99 lakh per annum, 48 "Super Dream" offers with packages between ₹7 and ₹9.99 lakh per annum, and 14 prestigious "Marquee" offers with packages of ₹10 lakh per annum or more. Among the top ten companies offering salary packages above ₹10 lakh per annum are notable names such as RtCamp, NASDAQ, Fintech Global, Federal Bank, and Ujjivan Small Finance Bank.

# **Internationalisation**

Marwadi University has made significant strides in the area of Internationalization, establishing a strong global presence through strategic partnerships and academic collaborations with renowned institutions worldwide. These efforts have enabled student and faculty exchange programs, joint research projects, and global internships, offering our students invaluable international exposure. During the year 2023-24, Marwadi University initiated 9 new collaborations with foreign universities and hosted 19 diplomatic and international delegation visits. Additionally, MU officials undertook 10 international visits, and 25 students participated in various student exchange programs.


Throughout the year, the Sports and NCC domain hosted 74 club activity events, engaging 2,501 participants. In addition, 140 competitions across sports, cultural, and co-curricular activities were conducted, with 3,545 individuals taking part.

# Staff Welfare

Marwadi University places great emphasis on staff welfare, ensuring a supportive and nurturing work environment that promotes both professional growth and personal well-being. We offer a range of initiatives, including health and wellness programs, professional development opportunities, and staff engagement activities, designed to enhance job satisfaction and work-life balance. Regular feedback mechanisms and open communication channels ensure that the needs and concerns of our staff are addressed promptly. By prioritizing staff welfare, we create a positive and productive atmosphere that fosters loyalty, motivation, and a strong sense of community within the institution.

During the year, a total of 211 staff members were hired, including 64 non-teaching and 147 teaching personnel. To support the integration of these new hires, 12 induction programs were organized, engaging 180 participants. Additionally, 10 staff engagement activities were conducted, with over 3,100 participants, fostering a sense of community and collaboration among the university staff.





# **Outreach Activities**

As part of our outreach activities, we have successfully organized 142 Career Guidance Seminars to assist students in making informed career choices. Additionally, we conducted 19 workshops and facilitated 19 campus visits to provide immersive learning experiences. Our participation in 24 education fairs has strengthened our engagement with prospective students, while 14 Teacher's Meets have fostered valuable collaborations and knowledge exchange.

#### Faculty Development

Our faculty members have achieved remarkable recognition both nationally and internationally, with a total of 37 noteworthy accomplishments. These include being featured in the Top 2% of Research Scientists, receiving Best Paper and Editor Awards, and earning SHODH Fellowships. Additionally, faculty members have been honoured with Academic Excellence Awards and have actively participated in various international conferences. Notably, some have received the IUCEE – IGIP Recognition as an Engineering Educator award and have been awarded international research grants. Furthermore, one of our esteemed faculty members was recognized with the IEEE Women in Engineering Inspiring Member 2024 award, highlighting the outstanding contributions and commitment of our faculty to their fields.



A total of 221 faculty members participated in 513 conferences, seminars, and Faculty Development Programs (FDPs) throughout the year, reflecting our commitment to continuous professional development. These opportunities enabled faculty to enhance their knowledge, share research findings, and engage with experts in their fields. This active participation underscores the university's dedication to fostering an environment of lifelong learning and academic excellence among its faculty.

# Ranking/Rating/Accreditation/Awards

Marwadi University has achieved significant recognition in various rankings, ratings, and accreditations. We received an **A+ grade from NAAC** with a CGPA of 3.31 on a four-point scale in our first cycle, making us the highest-ranking institution in the region. Additionally, we have been recognized as a **Scientific and Industrial Research Organization** (**SIRO**) by the Department of Scientific and Industrial Research (DSIR), Government of India. Our University was also chosen as a **Knowledge Partner for the Vigyan Jyoti Programme**, a flagship initiative by the Department of Science and Technology (DST), Government of India, aimed at encouraging meritorious girls to pursue education and careers in underrepresented areas of STEM. Furthermore, our Faculty of Law was ranked among the **Top 100 Indian Law Schools** by the Business World Law School Ranking 2024, receiving a Certificate of Excellence and securing the 12th position among private universities in the West Zone of India. Lastly, we have been granted Testing Accreditation by the National Accreditation Board for Testing and Calibration Laboratories, reflecting our commitment to maintaining high standards in testing and calibration.

#### **Infrastructure**

During the academic year 2023-24, Marwadi University saw several significant infrastructure developments. The new hostel building expanded its capacity by 700 beds to accommodate more students. Power distribution was also upgraded with the installation of an 11 KV compact substation and the addition of a dedicated electrical panel room building. Sports facilities were enhanced as well, with the cricket ground now featuring a dedicated box cricket yard for practice. Improvements were made to the campus water distribution and treatment systems, increasing both capacity and efficiency. Additionally, a new Boardroom, along with the Former Registrar's Office and the Provost's Office, was developed in the Satyarthi Building.

# Future Plans-Vision 2027

At Marwadi University, our vision for 2027 is anchored in excellence, innovation, and global recognition. By this milestone year, we aim to expand our student community to 25,000 learners, secure a position among the top 100 institutions in the NIRF rankings, and achieve a spot in the top 800 universities globally and the top 50 in India as per QS World Rankings. Additionally, we aspire to be ranked within the top 500 in QS Asia Rankings and attain the prestigious AACSB accreditation for our management programs, underscoring our commitment to delivering world-class education.


