Minutes of the 04th Meeting of Board of Governance Held on 26th June, 2017

The 04th Meeting of the Board of Governance was held on 26th June, 2017 at 11:00 AM at the Central Board Room [MC-301] of Marwadi University. The meeting was Chaired by Mr. Ketan Marwadi, President, Marwadi University.

The Provost, Dr. Y P Kosta, welcomed the Chairperson Mr. Ketan Marwadi and all the distinguished members of Governing Body.

The Agenda for the day was taken up as below:

<u>Item No. 1</u> – Establishment of Pharmacy Institute.

Looking upon the advancement in medical science and demand of study for pharmacy among the aspiring students, the need for setting up of institute for pharmacy studies has been felt in the region. It was suggested and recommended to the board for approval, for setting up of 4 year full time B.Pharm course under Marwadi Education Foundation's Group of Institution's - Faculty of Pharmacy affiliated to Marwadi University. The board is also requested to accord approval to allocate 2.5 acres of land and financial assistance for procurement of equipments, furniture and other required entities for the smooth functioning of the Institute.

The board considered the recommendation, discussed and resolved as below:

RESOLVED that the Marwadi University shall apply to Pharmacy Council for commencing Faculty of Pharmacy under Marwadi Education Foundation's Group of Institutions affiliated to Marwadi University.

<u>Item No. 2</u> – Establishment of Faculty of Law – B.Com LLB(Hons.) & B.A LLB(Hons.)

It was recommended and suggested to the Board, for commencement of Faculty of Law - B.Com LLB(Hons.) & B.A LLB(Hons.) instead of B.Com LLB & B.A. LLB and to offer education in 5 Year full time course. The necessary approvals will be obtained from Bar Council of India. Further, it was requested board to approve infrastructural facilities and financial assistance for the smooth functioning of the Institute.

The University shall also encourage for students and faculty exchange programs within the collaborated overseas universities. It was also proposed to send students to Poland and Germany as well as 2 faculty members shall be identified and encouraged to visit. The expenses towards students and faculty exchange programs shall be put up and accorded for approval from the members present in the Board.

RESOLVED that, the proposal for appointment of Head, International Relations shall be undertaken on an immediate basis. Students and faculty members shall be motivated and encouraged for exchange programs. The expenses incurred shall be approved by the Management Team of University.

It was informed to the members of Board regarding fees revision and the announcement made by Fees Regulatory Committee inviting proposals for fees structure for Academic Years 2017-18, 2018-19, and 2019-20. While deriving the fees structure income and expense projections were also taken into consideration along with implementation of seventh pay commission and its impact on salary revision. Subject: Appointment of Internal Complaint Committee (ICC) as per THE SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013 ACT NO. 14 OF 2013



Reference: THE SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013 ACT NO. 14 OF 2013

The Vishaka Guidelines were a set of procedural guidelines for use in India in cases of sexual harassment. They were promulgated by the Indian Supreme Court in 1997 and were superseded in 2013 by the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013. This act is to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment and for matters connected therewith or incidental thereto. The protection against sexual harassment and the right to work with dignity are universally recognised human rights by international conventions and instruments such as Convention on the Elimination of all Forms of Discrimination against Women, which has been ratified on the 25th June, 1993 by the Government of India.

Marwadi University hereby appoint Internal Complaints Committee as per the Sexual Harassment of Women at Workplace (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013 ACT NO. 14 OF 2013.

The Presiding Officer and every Member of the Internal Committee shall hold office for such period, not exceeding three years, from the date of their nomination

The Member appointed from amongst the non-governmental organisations or associations shall be paid such fees or allowances for holding the proceedings of the Internal Committee, by the University.

Any aggrieved woman (a woman, of any age whether employed or not, who alleges to have been subjected to any act of sexual harassment) may make, in writing, a complaint of sexual harassment at workplace to the Internal Committee appointed above within a period of three months from the date of incident and in case of a series of incidents, within a period of three months from the date of last incident: Provided that where such complaint cannot be made in writing, the Presiding Officer or any Member of the Internal Committee shall render all reasonable assistance to the woman for making the complaint in writing. ICC should adhere to all process specified in the above referred act and take steps accordingly.

It was suggested and recommended to the board for approval, for setting up of 4.5 years full time B.PT course under Marwadi Education Foundation's Group of Institution's - Faculty of Physiotherapy affiliated to Marwadi University. The board is also requested to accord approval to allocate infrastructure and financial assistance for procurement of equipments, furniture and other required entities for the smooth functioning of the Institute.

The board considered the recommendation, discussed and resolved as below:

Resolution:

RESOLVED that the Marwadi University shall apply to Gujarat State Council for Physiotherapy for commencing Faculty of Physiotherapy under Marwadi Education Foundation's Group of Institutions affiliated to Marwadi University.

Further, **RESOLVED** that funds and infrastructure as per statutory requirement will be allotted as per the need for the program.

<u>Item No. 4</u> – Starting of New Programs – B.Tech –Computer Engineering (Big Data and Analytics), Computer Engineering (Artificial Intelligence) & Agriculture Engineering.

The proposal for starting of new programs in B.Tech course was put-up for consideration and approval from the Board Members. The said programs were proposed on the basis of demands shown among aspiring students in the region. It was shared that the programs will have intake of 60 seats each.

It was suggested and recommended to the board for approval, for setting up of 4 year full time B.Tech courses under Marwadi Education Foundation's Group of Institution's - Faculty of Technology affiliated to Marwadi University. The board is also requested to accord approval to allocate financial assistance for procurement of equipments, furniture and other required entities for the smooth functioning of the program.

The board considered the recommendation, discussed and resolved as below:

RESOLVED that the proposed programs shall be approved for commencement within Faculty of Technology under Marwadi Education Foundation's Group of Institutions affiliated to Marwadi University.

Item No. 5 - Changes in seat intake;

- 1] Increase in intake in ICT from 30 seats to 60 seats.

Geotech Engineering has also its application in other disciplines which are concerned with construction occurring on the surface or within the ground. Looking upon infrastructural advancement and demand of Geotech Engineers in the professional area, it was proposed and recommended to the board members for its approval for introducing Masters in Engineering program in Geotech Engineering.

To initiate with, the proposed student seat intake was 18 seats. The board members were requested to consider the same and requisite infrastructure and financial assistance shall be provided for the smooth function of the Institute.
