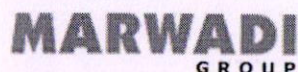

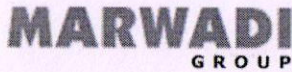

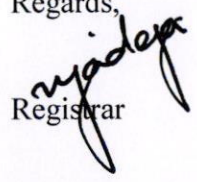

Item No. 14 – Choice Based Credit System.

Dr. R B Jadeja, Dean-Faculty of Engineering presented detailed Marwadi University regulations Governing Academic Programs under Choice Based Credit System (CBCS). CBCS is a flexible system of acquisition and imparting of knowledge based on the choices. It provides opportunities to students and teachers to have more space for choosing courses suiting their academic preferences and interest. CBCS Course structure for B.Tech Program along with total 200 credits with contact hours of 25-30/ week + 5 hours Academic Guidance/Personal counseling was also shared and discussed with the members present in the meeting. The detailed Regulations has been presented as an Annxure.

CBCS is offered to all the regular students admitted to Marwadi University from the Academic Year 2018-19.

The members present discussed and resolved as below;

Resolution:

- To rename/reframe courses of curricular of all programs as Foundation/Prerequisite.
- CBCS model as suggested by UGC may be implemented in M.Tech, MBA, M.Ss, B.Tech, B.Sc and MCA. The Deans of FoE/FMS/FAS/FCA shall discuss out the execution and report to Provost. Dean, FOE shall co-ordinate.
- Every Faculty shall introduce such courses which may be audit/credit and can be offered cross the University. It should be facilitated by having slots in regular time-table. Deans, of Faculties shall suggest such courses. This shall be undertaken within a month's time.
- To explore possibility for introducing model CBCS for UG programs.



Item No. 15 – Deep Learning and AI Skill and Research.


The details on nationwide initiative of Royal Academy of Engineering, UK under Newton Bhabha Fund on “AI and Deep Learning Skilling and Research” was shared among the members present in the meeting. Brunel University and University college of London and Bennett University, India are the collaborators of the project. NVIDIA and AWS Educate, Videoken and Edvantics are the Industry partners. Looking upon the merits of the Initiative, AICTE has approved and recommended the Institutions to associate with the project. The project will have approximately 10 collaborators, 100 lead zonal partners and 1000 basic partner institutions, 10000 teachers and 10 lakh students.

Marwadi University is one of the Zonal Lead Institute in this project. It was shared that the interested faculty members to collaborate in the program shall share their profile to Dr. Amit Lathigara, Head CE & IT.

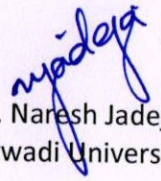
